

MINUTES OF CLOSING AND RECEIPT OF PROPOSALS INTERNATIONAL OPEN BIDDING PROCEDURE No. 001-2024

OBJECTIVE: To contract the "Supply of a Secondary Nitrous Oxide (N2O) Abatement System for the Nitric Acid Plant of Monómeros, located in the Special, Industrial and Port District of Barranquilla, Department of Atlántico - Colombia, in the context of the Nitric Acid Climate Action Group (NACAG) initiative".

On June 26, 2024, at 2:00 p.m., the CLOSING HEARING AND RECEPTION OF OFFERS OF INTERNATIONAL OPEN BIDDING PROCEDURE No. 001-2024 was held at the legal office of the company Monómeros Colombo Venezolanos S.A., located at Via 40 Las Flores in the city of Barranquilla - Atlántico, Colombia.
