1. CONDUCT OF THE HEARING

The undersigned, Process Engineer Alexis Morales, acting as Project Leader appointed by Monómeros S.A., proceeds to **OPEN** and install the hearing for the assignment and definitive distribution of the risks of the International Open Bidding 001-2024.

3. READING OF EACH OF THE RISKS IDENTIFIED, ASSIGNED AND ESTIMATED IN THE RISK MATRIX PREPARED BY THE COMPANY MONÓMEROS.

The undersigned delegate of the Technical Management of the company Monómeros S.A., proceeded to read the risks identified in the process of the International Open Bidding 001-2024.

The delegate leaves on record the publication of the Matrix containing the risks identified in this selection and contracting process, which was made known to interested bidders, through publication on the company's website, as of April 1, 2024.

The supplier interested in the present hearing acknowledges and accepts to know the risk matrix published by the company Monómeros. In the same sense, it states that it has no observations or request for modification to the risk distribution presented by Monómeros.

4. INTERVENTION OF THOSE ATTENDING THE HEARING

The attendees were informed that they could speak for a maximum of three minutes, during which time they had to activate their camera, indicate their full name and the company to which they belong in order to make their speech.

It is noted that there are NO comments from the attendees on the risk matrix.



5. CLARIFICATION OF THE DEFINITIVE BIDDING DOCUMENTS.

In order to guarantee the greatest transparency and equality in this selection process, the company proceeded ex officio to provide a space for interested parties to prepare and submit their questions or additional comments on the contents of the Final Bidding Terms and Conditions and its annexes, making it clear that, at each stage of this bidding process, timely responses have been given to the comments received.

The attendees were informed that the floor would be given to the interested parties in the same order and for the same term as in the transfer of risks, so that they may request any clarifications to the bidding documents that may be necessary.

It is noted that **Ricardo Polelti**, representing CASALE, made a technical comment, asking if it is possible to have more information on the current basket, since his proposal for the use of a secondary catalyst contemplates using the current support.

In consideration of the technical observation received, Monómeros hereby informs that, in order to fully address the same and provide a substantive response, a document containing the same will be published on the website, so that suppliers may verify it before submitting their bids.

6. TERMINATION OF THE HEARING.
