

PRELIMINARY EVALUATION REPORT ON QUALIFYING REQUIREMENTS INTERNATIONAL OPEN BIDDING PROCEDURE No. 001 – 2024

OBJECTIVE: To contract the "Supply of a Secondary Nitrous Oxide (N2O) Abatement System for the Nitric Acid Plant of Monómeros, located in the Special, Industrial and Port District of Barranquilla, Department of Atlántico - Colombia, in the context of the Nitric Acid Climate Action Group (NACAG) initiative".

e) CAPACITY, EXISTENCE AND LEGAL REPRESENTATION

with the appropriate document issued by the competent authority in the country of its domicile no earlier than three (3) months from the date of presentation of the Offer, in which it is evidenced that the legal representative has no limitations to contract obligations on behalf of the legal entity, or by providing the corresponding authorization or document of the direct corporate body that empowers him/her. This document shall be used to verify:

That the object of the company includes the main activities that are the object of the present process.

The duration of the partnership (singular-plural proposer) must be at least **three (3) years prior** to the opening date of this Bidding.

Note 2: When the documents provided by the foreign legal entity to prove the existence and legal representation do not have all the required information, they may attach a certification signed by the legal representative of the foreign legal entity with the missing data, which is understood to be submitted under oath.

f) CONSTITUTIVE DOCUMENT OF THE CONSORTIUM OR JOINT VENTURE OR PROMISE OF FUTURE PARTNERSHIP IF THE BIDDER IS PLURAL (FORM N° 6)

In which the participation of each of the members of the plural Bidder, the legal representation of the plural Bidder or the power of attorney granted to the person who subscribes the documents on behalf of the plural Bidder, if this is the condition of the bidder, must be stated.

When participating in a Consortium or Temporary Union, they may designate a single common representative and, in such case, the presentation of the document of formation of the Consortium or Temporary Union, signed by all the members, shall be sufficient for all purposes.

1.4 TECHNICAL CAPACITY VERIFICATION.

Technical prerequisite no. 3:

The Bidder must provide at least three (3) contracts or equivalent documents whose termination date is within the last twenty (20) years prior to the closing date of this contracting process, in which within its object, scope and/or list of activities, there is evidence of experience leading and/or supplying systems for secondary abatement of Nitrous Oxide (N_2O) or design and manufacture of Ammonia oxidation reactors (N_3) or Nitric Acid Production Plants.

NOT COMPLIANT

The bidder does not attach documents evidencing experience in the design and/or supply of secondary abatement systems or the design and manufacture of ammonia oxidation reactors or nitric acid production plants.

Technical prerequisite no. 4:

"The Bidder shall offer a warranty of **at least two (2) years** against manufacturing defects of the basket, which covers spare parts, accessories and other contracted goods. This warranty shall be effective from the date of delivery to satisfaction. Therefore, by means of this warranty this bidder shall be obliged to replace any component of the basket that is required due to manufacturing defects or poor quality."

COMPLIANT

The supplier includes a conditional in the warranty period where it limits the warranty period to 30 months, which starts to count from the moment the contracted goods are delivered. "SELLER warrants from any apparent and/or hidden defects of materials and workmanship supplied by SELLER for a period of 24 (twenty-four) months from installation, but not more than 30 (thirty) months from delivery, whichever occurs first".

Technical prerequisite no. 5:

The Offeror must certify that the secondary abatement catalyst included in its proposal is of a proven reference with more than 5 years in the nitric acid industry.

NOT COMPLIANT

The Bidder does not attach technical documentation of the catalyst to be used in the project, nor information showing that it has been used for more than 5 years in the nitric acid industry.

3. REQUIREMENTS AND OBSERVATIONS TO THE PROPONENT:

Within the term established in the schedule to correct the minimum qualification requirements in each of its legal, technical, financial and organizational components, the evaluation committee **REQUIRES** the company CASALE to proceed to correct and submit the documents that support the compliance of each and every one of the requirements established in the tender process, in order to continue with the evaluation process of its offer.

It should be noted that the company Monómeros provided throughout the tender process, the forms with which the bidder can more easily prove the minimum requirements requested.

In relation to the legal capacity requested, the bidder must provide the information required in the downloadable forms 1 to 7. It is at the discretion of the bidder to use its own formats or those suggested in the annexes in reference.

The bidder may submit the financial information listed above by filling out Form 9-Accreditation of the Bidder's Financial and Organizational Capacity.

Please note that in order to accredit the technical requirements related to experience, a copy of the contract certificates, order forms, contract completion certificates, client references, etc. must be submitted or delivered. In addition, you must fill out the downloadable form number 8.

As a consequence of the foregoing, a non-extendable term is granted until July 19, 2024 to correct and prove compliance with the mentioned requirements.
